RLI Financial Report – 2014 Budget and Dues

The RLI financial report is provided with your fall newsletter (page 2) and also on the second page of the Fall General Membership Meeting agenda. The report contains three sections – 2014 year to date (actual), 2014 year end forecast, and 2015 budget.
