RLI Financial Report – 2018 Budget and Dues

The RLI financial report is provided with your fall newsletter (page 2) and also on the second page of the Fall General Membership Meeting agenda. During the Fall General Membership Meeting the 2018 proposed budget will be reviewed, explaining anticipated expenses, and a request to approve the proposed 2018 budget and dues will be made.
